Ian has over 40 years' experience as a Loss Adjuster. After specialising in Construction and Engineering claims for the last 23 years, Ian has dealt with all classes of cases – from building collapses to major infrastructure claims, and claims against building consultants, architects, engineers and construction companies. Case highlights include:

Claim for repairs to a geothermal power station – quantum in excess of \$150m:

This claim involved alleged errors and omissions in the design of various aspects of a geothermal power station during its construction. The complexity of the project required efficient and effective management of significant volumes of information/documentation, and to review issues relating to loss mitigation works relative to the operation of the PI policy. Ultimately a substantial part of the claim was withdrawn and only a relatively small settlement made.

Claim for repairs to a coal loader dump station – quantum in excess of \$38m:

The claim resulted from alleged deficiencies in specialist subcontractors works resulting in flooding of a dump station under construction. Ian was involved in investigations as to causation and also quantum of the main claim as well as settlement of the specialist subcontractors' claims, which were in excess of \$2m.

Damage to sewer lines caused by tree roots – quantum \$65.00:

The number of zeros at the end of a claim do not necessarily make it memorable or difficult, but relevant stakeholders may do. The claimant was irascible, the local Council, after a year of argument, ranging between angry and bored. Ian attended a site meeting with Council officials but neither party would converse. To break the impasse, he went inside with the claimant's plumber, agreed a quick scope and price, came out and told them all we had settled it for \$65.00.

High value civil infrastructure claims – quantum in excess of \$20 million:

Simon has been involved with a significant number of claims of varied value and complexity. He has managed a number of high value civil infrastructure claims for road instrumentalities, including a package of storm damage losses which were claimed at over \$20m which occurred over a period of nine months.

High value building claims – quantum in excess of \$1 million:

Simon has also managed a number of higher value (\$1m+) building claims including collapse of scaffold during the build of a major bridge construction in the ACT – the damage that resulted included the scaffold, formwork and the partially placed concrete deck.

The collapse of a 10m high wall:

Other substantial losses he has dealt with include the collapse of a 10m high wall from a neighbouring property which was being demolished which fell onto a formed deck – the damage included formwork, new concrete slab works and in slab services.

Ben has been involved in a broad spectrum of Construction and Engineering claims ranging from civil infrastructure projects including bridge claims, soil stabilisation issues, and electrical infrastructure to high rise and waterproofing. Case highlights include:

Errors in structural design:

A claim involved errors and omissions in relation to a structural design, for a multimillion dollar commercial building, by an engineering consulting firm. The claim required detailed engineering analysis to review the claimed rectification works and ensure cost effective measures were adopted and implemented.

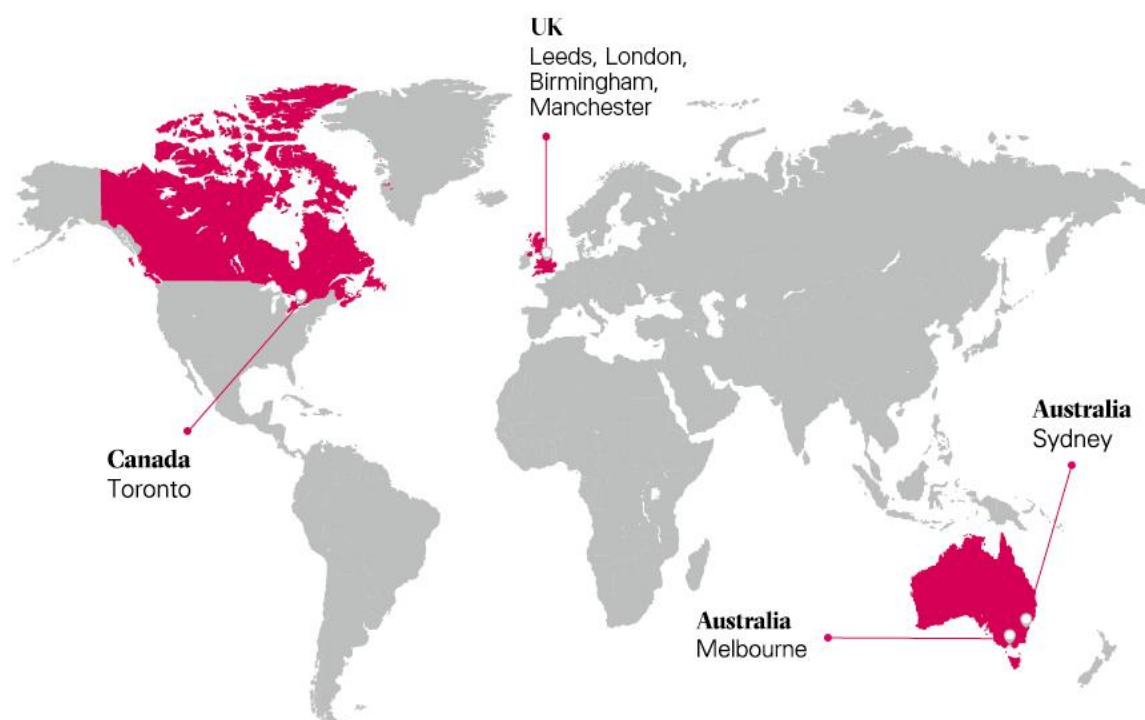
Water infiltration:

A high end residential dwelling had various issues relating to water ingress and cracking within the building. Ben defended allegations made against one of the subcontractors by carrying out detailed investigative work of a highly technical nature whilst communicating effectively with various stakeholders.

Building collapse

Collapse of a building that was undergoing refurbishment as part of the insured's contract works. The collapse resulted in damage to a number of Third Party properties. The claim required in-depth engineering knowledge to determine causation and assess the costs to rectify the damage.
